Meeting Minutes <u>March 2020</u>

If we have 150 horses or greater, we would no longer be considered a Value Show for 2021.

**Qualifications:** 

-Qualifications are dismissed up to May 10, 2020. If entries were pre-paid then the exhibitor would automatically be qualified.

At this point, this does not apply to Region 10, since the show is scheduled after May 10th.

### **Royalty:**

Jaime L. reported on the Royalty.

-The Royalty shirts have arrived and have been received by our Royalty.

-Due to COVID-19 there will be less events for the Royalty to attend, such as MN Horse Expo.

-The 2021 Royalty Guidelines and Application are available. Deadline is May 15, 2020.

### **Region 10 and NMAHA Youth Fundraiser:**

Kaitlyn F. reported on the Fundraising.

-Region 10 Youth fundraising has been pushed back and other options are being explored.

- · Announcer assistant halter score tabulators


